

## MSc Logistics

### Course Aim

The MSc in Logistics is a postgraduate qualification, which aims to provide Learners with the knowledge and understanding required to deal with the constant challenges within global logistics at the strategic level. It is designed around three themes: logistics, business management and research.

### Entry Eligibility

The normal entry requirements for admission to the MSc programme are typically:

- Completion of the WO CLM course with accompanying suitable evidence relating to skills, achievements and life experiences (CV).
- An Honours degree or equivalent in an appropriate discipline.
- CILT (UK) Advanced Diploma combined with relevant experience.
- Equivalent qualifications such as a good HND with at least 5 years relevant experience.

The University maintains active links with professional bodies such as The Chartered Institute of Logistic and Transport (CILT) UK.

### Duration

The course commences each September and typically takes 24 - 36 months to complete, depending on work commitments and personal circumstances. A flexible approach is applied to allow Learners to take breaks in study based on work and life commitments albeit the total time permitted to complete the degree is five years from the date of registration.

### Cost and Payment

Course provided at reduced cost for Postal and Courier Operator personnel:

Payment	£3,150 payable once prior to year one and once prior to year two

### Available Funding

### Method of Delivery

Face-to-Face delivery at the University, live online webcasts or lessons recorded and available online.

Logistics:

- Logistics Strategies and Operations.
- Sustainable Logistics.
- Logistics Modelling.

Business:

- Financial Management and Contract Law.
- Management of Human and Organisational Resources.

### Part 2

Research:

- Dissertation.

## Assessment

Assessment methods for Part 1 of the programme include a variety of written formats from essays (ranging from 1,750 words up to 2,750 words in length), oral presentations delivered both in a group and individually, and one unseen examination.

Part 2 of the programme comprises the learner's individual research project and is assessed by the formal research proposal, the dissertation and a viva voce examination.

## Tutor Support

In addition to lecturer support, cohorts are encouraged to work together as a team. A Facebook Group is also available and restricted to students and staff. Each student has a dedicated tutor allocated to provide a consistent point of contact. Additional support is available from module tutors (if these are different from the personal tutor), the full range of student support services already available within the university.

## Equipment Required

A range of resources are provided through the Virtual Learning Environment (VLE). No additional resources are required by the learner with the exception of access to the internet through a modern personal computing device.
